






Dear parents and carers,

Coronavirus

Below is a reminder of the information sent to you last week about the obligations of schools as part of contact tracing, and what you would need to do as parents in reporting a positive case.

Public Health England has agreed a six-day window after the final day of teaching in which schools and further education providers are asked to remain contactable so they can assist with contact tracing where necessary. This will allow enough time for positive coronavirus (COVID-19) cases to be identified and confirmed by a test and for relevant contacts in the education setting to be traced.

- Where a pupil or staff member tests positive for coronavirus (COVID-19), having developed symptoms more than 48 hours since being in school, the school should not be contacted. Parents and carers should follow contact tracing instructions provided by NHS Test and Trace.
- For the first six days after teaching ends, if a pupil or staff member tests positive for coronavirus (COVID-19), having developed symptoms within 48 hours of being in school, the school is asked to assist in identifying close contacts and advising self-isolation, as the individual may have been infectious whilst in school. For our school the arrangements are as follows:

Parents are asked to contact Rebecca Abrahams on her mobile phone (07932 995213) at any time until 5pm. On Christmas Eve, the final date for which schools need to be involved in contact tracing, Rebecca will be available until 3pm. All other parents and staff who need to be informed of a positive case which could impact them, will be informed by text message from the school.

School staff are not asked to remain on-call or conduct any contact tracing more than six days after the final day of teaching.
Our school's last teaching day is on Friday 18th December, therefore there should be no pupil contact tracing asks beyond Thursday 24th December.

You should have received a text message earlier in the week to inform you that we will be having an additional INSET day at the start of next term.
